I, the undersigned, in connection with my participation on 2022 in the event ROUND TRACK MASTERS 2022 taking place on the track (hereinafter referred to as "Event"), I hereby declare that:

1. I participate in the Event at my own risk and responsibility,
2. I know the regulations of Track Masters 2022, I accept their provisions in full and undertake to strictly comply with them,
3. I know the risks associated with participation in car races and automotive events,
4. in the event of an accident or any other incident during which I will be injured in any way, I will not make any claims against the organisers of the Event or any persons cooperating with them during the Event,
5. I have been instructed about the nature of the Event, the rules of the Event and the required conduct during the Event,
6. I undertake to follow the instructions of the persons organising the Event throughout its duration,
7. I am sober and not under the influence of drugs or substances that would impair my ability to drive motor vehicles,
8. I have not been diagnosed with mental and physical disorders that make it impossible to drive motor vehicles,
9. I take full and sole responsibility for the health and life of passengers who are present in the car while driving it on the track.

I undertake to:

1. drive safely with particular regard to the safety of others on the trial area and race track,
2. be responsible for damage intentionally and unintentionally caused to these persons or their property arising from my presence on the track,
3. **I undertake to pay the costs of repairing any damage to the track infrastructure that occurs through my fault,**
4. **not to change my lane when overtaken by faster vehicles,**
5. **not to travel on the track against traffic,**
6. **to allow being overtaken by faster drivers,**
7. **to leave the track at the request of a designated person or as agreed during the check-in,**
8. **to signal a failure of the vehicle being driven by means of hazard warning lights,**
9. **to immediately pull over to the grass when suspecting or discovering any leak in my car**
10. **to give way to cars on the track when exiting the depot onto the track,**
11. **not to exceed the speed limit in DEPOT of 20 km/h and not to cross the white line of exit from the Depot,**
12. **pay an additional fee of PLN 1,000 for breaking the security rules (for each breach).**

I declare that I am aware that:

1. persons organising the Event are not responsible for any actions or omissions of the Event participants towards each other or third parties during the Event in any respect,
2. breaking the rules of conduct during the Event in a way that might endanger the safety of other participants results in the participant's immediate exclusion without the right to a refund of the participant's contribution.

- NOTE! Helmets are COMPULSORY for the driver and the passenger, if any!!!
- NOTE! Only those cars will be allowed to drive on the Track that generate noise NOT higher than the limit specified in the track regulations under the measurement conditions (2/3 of the maximum speed not less than 3800 rpm, 1/2 m from the exhaust outlet or dynamic measurement of a moving car). The sonometer measurement will be performed before and during the rides (dynamic measurement). Cars that do not meet the above requirement will not be allowed to drive.
- NOTE! All vehicles out on the track must have towing handles installed!

I accept and will respect the provisions of the above declaration and the rules applicable during the event.

I, the undersigned, pursuant to Article 81 section 1 of the Act on Copyright and Related Rights of 4 February 1994 (i.e. Journal of Laws of 2006, No. 90, item 631, as amended), give consent for my image and the image of my car to be recorded free of charge in the form of analogue and digital photography and film footage in a photographic session conducted by persons acting on behalf of the Miata Challenge Organiser during the given ROUND.
